

ASHFIELD ANTI-POLL TAX UNION NEWS

DEAR MEMBERS AND FRIENDS,

BY NOW, MOST OF YOU WILL HAVE RECEIVED YOUR FINAL DEMAND TOGETHER WITH THE THREAT OF POSSIBLE COURT ACTION TO FOLLOW IF THE "DEBT" IS STILL NOT PAID. IF YOU GET A SUMMONS, LET YOUR LOCAL ANTI-POLL TAX UNION KNOW AT ONCE TO GIVE THEM TIME TO ADVISE YOU FURTHER. IT IS ENTIRELY UP TO YOU IF YOU ATTEND COURT, BUT IT IS IMPORTANT TO ATTEND TO SHOW DEFIANCE TO THE TAX AND THATCHERS GOVERNMENT, BY "DRAGGING" OUT YOUR CASE AS LONG AS POSSIBLE.

IF YOU DONT ATTEND COURT, A LIABILITY ORDER MAY BE GRANTED IN YOUR ABSENCE THEREBY GIVING THE COUNCIL CERTAIN POWERS TO RECOVER THE TAX YOU MAY OWE PLUS COSTS (WHICH WILL BE SHOWN ON YOUR SUMMONS).

THE FIRST OF ASHFIELD AND MANSFIELD NON-PAYERS ARE TO APPEAR IN COURT ON FRIDAY 9TH NOVEMBER AT 9.00am WITH 150 ASHFIELD CASES IN THE MORNING AND 150 MANSFIELD CASES IN THE AFTERNOON. THIS IS THE TIME TO SHOW YOUR SUPPORT IN ANY WAY YOU CAN TO THE ANTI-POLL TAX MOVEMENT PREFERABLY BY DEMONSTRATING OUTSIDE THE COURT FROM 9.00am ON FRIDAY 9TH NOVEMBER. IN NOTTINGHAMSHIRE, RUSHCLIFF, BROXTON GEDUNG AND SEVERAL OTHERS HAVE ALREADY BEEN TO COURT WITH ~~BAILIFFS~~ BAILIFFS NOW BEING USED IN AN ATTEMPT TO GET YOUR MONEY BUT AT PRESENT NOT ONE BAILIFF HAS GAINED ENTRY. THEY HAVE NO LEGAL RIGHT OF ENTRY ON THE FIRST VISIT. DO NOT LET THEM IN. IN GRANTHAM, THE LOCAL ANTI-POLL TAX UNION (WITH OTHER UNIONS) HAVE BEEN "SEEING THE BAILIFFS OFF" WITH HELP FROM WEEKS NOW WHICH HAS MADE THE COUNCIL VERY MAD, SO MUCH SO THAT THEY ARE NOW GOING BACK TO COURT ON THE 2ND NOVEMBER IN ORDER TO GRANT FURTHER POWERS TO RECOVER THE MONEY.

IT IS NOW OBVIOUS THAT THE LOCAL COUNCILS ARE MOST DESPERATE TO GET ANYTHING THEY CAN TO MAKE UP THE DEFICIT DUE TO NON-PAYMENT NOT ONLY OF ORDINARY PEOPLE BUT ALSO OF LOCAL BUSINESS TAX (NON-DOMESTIC POLL TAX). WE HAVE IT ON GOOD AUTHORITY THAT NON-PAYMENT OF THE BUSINESS "POLL TAX" WILL BE ADDED TO THE ORDINARY POLL TAX BILLS NEXT YEAR IN ASHFIELD. COUNCILLOR TIPPING OF NOTTS COUNTY COUNCIL HAS ALREADY STATED THAT THE COUNTYS BILL NEXT YEAR WILL BE £450 WITH THE LOCAL COUNCIL PUTTING THEIR "BIT" ON TOP. ASK YOURSELVES, CAN YOU AFFORD £450+ EACH NEXT YEAR. PLEASE DON'T BE FRIGHTENED BY THE HEAVY HANDED APPROACH OF THE AUTHORITIES TO COLLECT THIS MOST EVIL, ONE SIDED TAX, WE CAN ADVISE YOU AND GUIDE YOU THROUGH THIS COMPLICATED SYSTEM. AND REMEMBER, THE MORE PEOPLE THAT DONT PAY, THE BETTER THE CHANCE WE HAVE OF DEFEATING THIS TAX ONCE AND FOR ALL. ALSO REMEMBER, NOT ONE ~~COUNTRY~~ OTHER COUNTRY HAS HAD THE NERVE TO BRING IN A SYSTEM OF A POLL TAX WHERE THE POOR SUBSIDES THE RICH LIKE OURS AND STILL ENFORCING IT.
