

to the organisers of recent benefit events. An enjoyable evening at The Garage, raising funds for the ARC was closely followed by a hot and crowded one at The Yorker. Phew! This one realy packed them in. As a result £100 was raised for Nottinghams Hunt Saboteurs and another £100 for Veggies campaign against McDonalds. MANY THANKS to the organisers and to all the bands that supported these events.

It is interesting to note that if McDonalds had never chosen to threaten legal action against Veggies, they would have had the resources to produce only a few thousand leaflets. Now, thanks to public support enough has been raised to print 30,000 ! Any group or individual able to help distribute them - please get in touch.

DEMONSTRATIONS

As you will see on the events page the season for demos is starting up again. Several years ago the ARC regularly filled a coach for such events. VEGGIES NEWS

MARCH '88

Regular readers will know that in October 1987 Veggies Ltd, of Nottingham, received threats of libel action over allegations made in the leaflet What's Wrong With McDonald's.

The leaflet had said that Restaurants McDonalds implicated in the destruction of rain-forests for the production of cheap beef, and also implied that they were responsible for torture or murder of McDonalds solicitors animals. demanded that Veggies state that they were "satisfied that there is no truth whatsoever in these statements" and to "apologise to McDonalds Hamburgers Ltd for any embarrassment caused."

In November a strict time limit of 14 days was given to reply.

Following preliminary investigations, Veggies prepared a response conceeding that specific evidence of direct connection between McDonald's and the destruction of rainforests had not been found. the practice in the United States of labelling imported beef as 'US Beef', and McDonalds role in creating a worldwide demand for beef, meant that Veggies were unable to make a full retraction in the terms demanded.

Faced with the possibility of meeting McDonalds in the High Court, Veggies were also willing to to conceed that "the word 'murder' is not yet widely used in connection with the killing of animals, although by our standard this is indeed the case".



Together with this response, McD's solicitors were sent details of the voluntary and charitable nature of Veggies work. Their attitude now changed. They offered to discuss a 'mutally acceptable variation' of the required correction and invited Veggies solicitor to discuss the matter with them.

As a result they are willing to concider an apology on Veggies terms, on condition that, whilst conceeding lack of specific evidence on the rain-forest issue, details of the continuing doubt are not given. They also seem willing to accept Veggies position on the 'murder' of animals, so long as the word 'torture' is also retracted, whilst still allowing a statement to be made that Veggies are unable to excuse the suffering, cruelty and waste of life caused by the production of beef burgers.

Veggies suggest revising the What's Wrong With McDonalds, leaflet to change the words 'torture and murder' to 'slaughtering and butchering' and to redraft the rainforest section. Supporters are encouraged to give their views as to whether settlement on these terms is acceptable.

Big stores ban pork linked to cancer scare drug

A DRUG widely used by farmers in Britain to treat pigs has been linked with cancer and birth defects among laboratory animals in the United States.

While government experts wait to study evidence from America, stores, including Waitrose and Marks and Spencer, have already acted by insisting that the farmers who supply them do not add antibiotics to their pig-feed as a routine. Farmers who do not comply risk losing valuable contracts.

A spokesman for Waitrose said: "We appreciate and understand the use of antibiotics administered under veterinary supervision or during the weaning period.

"Our main concern is the use of antibiotic additives during the main rearing and finishing stages. We are committed to selling foods which are wholesome, safe and as natural as possible."

The Ministry of Agriculture, which has admitted that traces of sulphadimidine were "frequently detected" in British pig kidneys during recent tests by its food surveillance group, is worried that some farmers are not waiting long enough after treating their pigs before sending them to slaughter.

A spokesman said yesterday that the ministry was aware of the situation in America and was seeking a copy of the FDA report.

He said: "Meantime, it is important that all farmers observe the recommended 15 days withdrawal period before

This period is for antibiotics to work their way out of an animal's system. It is a voluntary code of practice, not a legal requirement.

There is already one marketing scheme in France which guarantees "natural" chickens free of additives and antibiotics.


